

# VAT Relief form



If you are chronically sick or disabled you can claim VAT Relief on Mangar Health products

VAT Relief is controlled by HM Revenue & Customs who say a person is ‘chronically sick or disabled’ if they:

- ✓ Have a physical or mental impairment that has a long-term effect on their ability to carry out everyday activities
- ✓ Have a condition that doctors treat as a chronic sickness (e.g. diabetes).
- ✓ Or are terminally ill.

Guidance on eligibility is available from the National Advice Service on 0300 200 3700

- You won’t qualify if you are only temporarily disabled or incapacitated, such as suffering from a broken leg or other temporary injury.
- Neither will you qualify if you are elderly but otherwise able-bodied and don’t suffer from any chronic condition

This form enables you to claim VAT Relief on any Mangar Health products you are purchasing.

Eligibility declaration by a disabled person

Please note there are penalties for making false declarations.

If you are in any doubt as to whether you are eligible to receive goods or services zero-rated for VAT you should consult Notice 701/7 VAT relief for disabled people or contact the National Advice Service on 0300 200 3700 before completing this declaration.
